## Dispute Resolution and Restorative Practices

**Attendance Mediation**: Responding to the challenges of truancy by bringing together parents and teachers to identify underlying issues and develop a collaborative plan to address these issues. The goal is to improve attendance by building communication between the family and school. Mediation is facilitated by a professionally trained adult volunteer mediator.

**Restorative Practices:** A strategy that works to repair relationships that have been damaged. The practice is facilitated in a circle setting, with all parties involved in the conflict participating in the circle. The goal is to acknowledge the harm done, have remorse shown for causing the harm and solicit forgiveness from the parties harmed. The circle is facilitated by a staff or volunteer person trained in Restorative Practices.

**Peer Mediation**: Problem solving by youth with youth. A process in which two or more students involved in a conflict meet in a private, safe and confidential setting to work out problems with a the assistance of a trained student mediator. A trained school staff person conducts intake and supervises the group of Peer Mediators. Common Ground's Youth Program Manager would be available to check in, answer questions, and attend to any needs the Peer Mediators may have.

**Parent -Child Mediation/PINS Diversion or Adjustment Services**: A meeting of parents and their child with a trained mediator to address many family issues.. These issues can include; curfew, peer relationships, discipline, household responsibilities, school problems, single-parent concerns, step-child/step-parent problems and girlfriend/boyfriend difficulties and minor criminal issues. Parents and Children between 9 and 18 years of age are eligible.
